Appointment of '**CONSULTANT**' under **VIGYAN PRATIBHA**

VIGYAN PRATIBHA is a novel initiative of Government of India for extended nurture of talent in Science and Mathematics among schools students of Class 8th to 10th in the country. The program is being implemented in Kendriya Vidyalayas (KVs), Jawahar Navodaya Vidyalayas (JNVs), and Atomic Energy Central Schools (AECSs) in the country. The core of the project would be in the form of Learning Units that will be implemented by school teachers in these schools as a part of science circles for interested students. These units will be closely related to the school curricula, but would expose students to dimensions of science and mathematics beyond the textbooks.

SCOPE OF WORK:

1. Liaisoning with S&T institutes
2. Academic support to school teachers by school visits
3. Facilitating science circle activities in schools, training programs of teachers, and exposure visits.

EDUCATIONAL QUALIFICATIONS:

Graduate / P.G. in Science or Mathematics with Graduation in Ed. / P.G. in Ed.

EXPERIENCE:

1. At least 7 years as teacher / faculty member in Chemistry / Physics / Biology / Mathematics.
2. At least 5 years of senior administrative position as Principal / Asst. Commissioner or higher in any of the above three education systems.

AGE LIMIT:

Candidate should not be more than 65 years of age on 1st July 2019.

NATURE OF APPOINTMENT:

1. The appointment is full time and will be purely on contract basis.
2. No accommodation or HRA will be provided.
3. The contract would be initially for 6 months and extendable for another 6 months.
