

TERMS & CONDITIONS

1. The buses should be in good condition, having good upholstery, finess, good type and comfortable seats.
2. The driver provided for the vehicle shall be in proper uniform. The concerned driver shall have a valid Driving License and a copy of Police Verification Certificate and he shall keep the same in this possession at all times, while on duty.
3. Driver should be in possession of mobile phones, so that they can be contacted by HBCSE members. The driver of the vehicle shall be well mannered, literate, always in uniform, well disciplined, behave properly, well conversant with the route/ road in and around Maharashtra. If the driver is found having consumed alcoholic drink or is unwell or not well dressed, he will not be accepted.
4. The driver will not be permitted to take vehicle/s for his meals, etc. and if so, it will be treated as breach of conditions of the Contract.
5. The Contractor shall ensure that driver does not carry any inflammable/contraband material in the vehicle.
6. The Contractor shall issue identification/Police verification letter to his drivers so that they are easily recognizable.
7. Driver should have thorough knowledge of traffic signals/ road safety precautions.
8. Safety and security of the vehicle is the sole responsibility of the Contractor.
9. Required: AC buses with storage trunk at the bottom.
